AFSCME LOCAL BARGAINING UNIT 1999 LABOR AGREEMENT 2024-2029

PROBLEM/NEEDS STATEMENT

The College and the American Federation of State, County and Municipal Employees Local 1999 reached a tentative agreement on the terms of a collective bargaining agreement for the Maintenance Staff on Thursday, July 18, 2024, ratified by the Union membership on Tuesday, July 23, 2024. The Board of Trustees must approve the tentative agreement for it to be effective.
